

# ADFX Christmas Campaign 2024

## Terms & Conditions

### 1. Campaign Period

The campaign runs from December 9, 2024 (00:00 server time) to December 27, 2024 (23:59 server time).

All time references are based on ADFX MT5 server time.

### 2. Eligibility

- Open to individual clients residing in Mainland China and Southeast Asia only.
- Participants must hold a verified live trading account with ADFX.
- Corporate accounts, PAMM/MAM accounts, and demo accounts are excluded.

### 3. Participation Requirements

To qualify for reward consideration, clients must:

- Deposit a minimum of \$200 USD into their ADFX trading account during the campaign period.
- Complete a minimum of 5 closed standard lots on FX or precious metals (gold/silver).
- Submit the official campaign application via [support@adfx.com](mailto:support@adfx.com) or your dedicated account manager before the campaign deadline.

### 4. Deposit & Trading Rules

- Only external deposits via approved payment methods are considered.
- Internal transfers or bonuses do not count toward the minimum deposit.
- Lot calculation includes only closed trades during the campaign period.

- Trading in indices & stocks are excluded.
